## Syarikat disyaki jalankan aktiviti penipuan pelaburan diserbu

**Kuala Lumpur:** Sebuah syarikat yang disyaki menjalankan aktiviti penipuan pelaburan diserbu pihak berkuasa semalam dan pelbagai kenderaan mewah dirampas.

Difahamkan, serbuan oleh Kementerian Perdagangan Dalam Negeri dan Kosara Hidup (KPDN) serta Bank Negara Malaysia

(BNM) itu dijalankan di pejabat serta kediaman pemilik syarikat di Subang, Selangor.

Sumber berkata, satu operasi dilaksanakan susulan laporan yang diterima berhubung aktiviti penipuan pelaburan membabitkan kerugian jutaan ringgit.

"Pasukan menyerbu pe-

jabat dan kediaman pemilik di kawasan Subang dengan beberapa kenderaan mewah seperti Lamborghini serta BMW dirampas.

"Pejabat berkenaan turut disita untuk siasatan. Setakat

ini, siasatan sedang dijalankan," katanya.

Sementara itu, difahamkan KPDN Putrajaya akan mengeluarkan ke-

nyataan media berhubung operasi berkenaan.

Syari-

kat pelaburan yang beroperasi sejak 2021 dan pernah mendatangkan perjanjian persefahaman dengan sebuah pasukan bola sepak bagi tajaan didakwa memperdaya mangsa menerusi skim pelaburan dan hibah dengan menjanjikan pulang lumayan.

Difahamkan, sejak ditubuhkan lebih 100,000 ahli menyertai skim pelaburan berkenaan

menyertai skim pelaburan berkenaan.

Bagaimanapun, pelabur yang menyertai skim itu tidak menerima pulangan dijanjikan.

Semakan mendapati, nama syarikat terbabit juga sudah dimasukkan dalam senarai amaran pelaburan oleh BNM dan Suruhanjaya Sekuriti (SC).

## Dua warga Thailand didakwa miliki 160 liter petrol

**ALOR SETAR:** Dua warga Thailand mengaku tidak bersalah di Mahkamah Sesyen sini semalam atas pertuduhan memiliki barang kawalan iaitu 160 liter petrol di Durian Burung, Padang Terap baru-baru ini.

Phatcharee Hama, 38, dan Abdulloh Saleesing, 21, kedua-duanya berasal dari Songkhla, Thailand yang didakwa secara bersiringan membuat pengekuan itu selepas pertuduhan dibacakan dalam bahasa Thai di hadapan Hakim Noor Zaihan Mohamad Ali.

Phatcharee didakwa memiliki barang kawalan berjadual iaitu 60 liter petrol yang dijumpai dalam tangki tambahan di bahagian tempat duduk belakang sebuah kenderaan bernombor pendaftaran tempatan, dalam

keadaan menimbulkan syak munasabah melanggar Peraturan 3 (1) Peraturan-Peraturan Kawalan Bekalan 1974 iaitu berurusan dengan barang kawalan secara borong tanpa lesen.

Abdullah juga didakwa melakukan kesalahan sama setelah didapati memiliki petrol berjumlah 100 liter dalam sebuah kenderaan lain yang turut mempunyai tangki ubah suai, dan mereka didakwa melakukan kesalahan itu di Sekatan Jalan Raya Durian Burung pada 11.45 pagi 27 Julai lepas.

Pertuduhan terhadap kedua-dua tertuduh dikemukakan mengikut Seksyen 21 Akta Kawalan Bekalan 1961 dan boleh dihukum di bawah Seksyen 22 (1) akta sama.

Jika sabit kesalahan mereka boleh didenda tidak lebih RM1

juta atau penjara maksimum tiga tahun atau kedua-duanya, dan bagi kesalahan kali kedua dan berikutnya, boleh diidam sehingga RM3 juta atau penjara tidak melebihi lima tahun atau kedua-duanya.

Hakim membenarkan setiap tertuduh diikat jamin RM10,000 dengan dua orang penjamin warga tempatan serta mengarahkan kedua-dua mereka melaporkan diri di balai polis terdekat setiap bulan dan menetapkan 4 September ini untuk sebutan semula kes.

Pendakwaan dikendalikan Pegawai Pendakwa Kementerian Perdagangan Dalam Negeri dan Kos Sarawak (KPDN) Mohd Hilmi Abu Hassan dan Mohd Sayuti Ismayatin, manakala tertuduh tidak diwakili peguam. — Bernama

# Companies involved in cartels penalised

**KUALA LUMPUR:** The Malaysian Competition Commission (MyCC) has imposed financial penalties of over RM570 million on nearly 100 companies involved in cartel activities in the country, Dewan Negara was told.

In a written reply to Senator Datin Ros Suryati Alang, the Domestic Trade and Cost of Living Ministry said the MyCC is investigating 18 cartel cases involving more than 500 enterprises, Bernama reported.

"Fourteen of the cases involve bid rigging in government procurement, with a value of more than RM3.3 billion."

The ministry said it would table a Bill to amend the Competition Act 2010, introducing a Merger Control Regime and strengthening the powers of the MyCC in the investigation of cartels.

"The regime is one of the early mechanisms proven effective to stop companies from using merger or takeover transactions with their competitors to form a cartel."

"The amendment Bill is expected to be tabled in Parliament in October."

# Tidak halang kemasukan pelabur

Kerangka kawal selia internet bantu rangsang pelaburan ke dalam negara

SINGAPURA

**K**erangka kawal selia baharu untuk penggunaan internet yang selamat tidak akan menghalang kemasukan pelaburan ke Malaysia.

Menteri Komunikasi, Fahmi Fadzil berkata, peraturan baharu yang akan dilaksanakan tahun hadapan itu akan menggalakkan pelaburan dengan menyediakan kerangka kawal selia baharu yang lebih jelas.

"Kami percaya ia mungkin merangsang pelaburan selanjutnya kerana landskap kawal selia menjadi lebih jelas apabila garis panduan ini ditetapkan," katanya dalam temu bual di akhir lawatan kerja tiga hari di sini pada Selasa.

Menjelaskan keputusan kerajaan memperkenalkan pelesenan, Fahmi berkata, ia berpunca daripada keperluan untuk mengekang penipuan, bahan penganiayaan seksual kanak-kanak (CSAM) dan buli siber di plat-

form ini terutamanya selepas kemati-an pempengaru media sosial, A Rajeswary atau dikenali sebagai Esha yang mencetuskan kemarahan orang ramai.

"Keputusan itu tidak dibuat dalam sekilip mata kerana libat urus dengan semua platform telah bermula pada Februari.

"Mereka juga diberi tempoh lima bulan mulai pengenalan kerangka kawal selia baharu pada 1 Ogos sehingga pelaksanaannya pada 1 Januari 2025 untuk mendapatkan lesen," katanya.

Sementara itu, Fahmi yang juga jurucakap Kerajaan Perpaduan ber-kata, setakat ini kerajaan tidak ber-cadang melanjutkan kerangka kawal

selia baharu mengenai internet se-lamat kepada platform e-dagang atau pasaran dalam talian.

Bagaimanapun beliau menyatakan Suruhanjaya Komunikasi dan Multimedia Malaysia (SKMM) bersedia bekerjasama dengan Kementerian Perdagangan Dalam Negeri dan Hal Ehwal Pengguna (KPDN) yang me-nyelia platform e-dagang di negara ini untuk menangani isu seperti penipuan di platform berkenaan.

"Kami mahu pasaran dalam talian, platform media sosial dan perkhidmatan pemesajan dalam talian mengambil pendekatan yang lebih proaktif untuk menangani kebimbangan ini jika mereka menggesa sebarang aktiviti je-nayah," katanya. - Bernama

## Semua kementerian disaran bekerjasama tingkat kesedaran

**SHAH ALAM** - Semua kementerian disarankan supaya bekerjasama dalam memainkan peranan melaksanakan program sosial bagi meningkatkan kesedaran orang ramai berhubung inisiatif dan bantuan penyasaran subsidi di negara ini.

Naib Presiden Gabungan Persatuan-Persatuan Pengguna Malaysia (Fomca), Datuk Indrani Thuraisingham berkata, tindakan meningkatkan kesedaran itu tidak sepatutnya diserahkan kepada Kementerian Perdagangan Dalam Negeri dan Kos Sara Hidup (KPDN) sahaja, sebaliknya memerlukan usaha secara bersepada

daripada semua kementerian.

"Ada banyak program yang telah kerajaan keluarkan, saya rasa sekurang-kurangnya ada 61 program sosial telah dikeluarkan tetapi semua ini dikeluarkan oleh kementerian berlainan dan mereka seolah-olah tidak berada dalam satu naungan yang besar.

"Jadi kita nampak ada pengasingan atau silo. Kadang-kala ada keluarga yang menerima bantuan dari tiga atau empat program, tetapi ada keluarga yang tidak terima apa-apa.

"Saya rasa Sistem Pangkalan Data Utama (PADU) yang telah diperkenalkan kerajaan itu adalah sistem yang amat bagus kerana ia boleh kenal pasti siapa golongan-golongan rentan yang boleh mendapatkan bantuan se-cukupnya," katanya.

Dalam pada itu, ujar Indrani, kerajaan juga perlu mengenakan hukuman lebih tegas kepada mana-mana peniaga yang cuba mengambil kesempatan menaikkan harga barang susulan penyasaran semula subsidi.

Menurutnya, meskipun pihak KPDN sedang mengawal atau melakukan pemantauan melalui Akta Kawalan Harga dan Anti Pencatutan (AKHAP) 2011 namun, ia belum mencukupi.

"Saya rasa hanya keluarkan notis sahaja tidak cukup, kita kena meng-enakan penalti yang begitu tegas.

"Sama ada menggantung lesen mereka atau memberi penalti begitu tegas. Sekarang hukuman penalti sangat terhad.

"Jadi kita kena pastikan supaya menegaskan mereka ini tidak mengambil kesempatan sewenang-wenangnya," ujarnya.

During his working visit to Singapore, Fahmi met with officials from various social media platforms such as Meta, Google, TikTok, and Tencent to update them on the new regulatory framework, and discuss online security, as well as potential collaborations to combat illegal activities on these platforms.

He also held bilateral talks with Singapore's Digital Development and Information Minister Josephine Teo. —Bernama
