CONFEST 2025 salur input Dasar Pengguna Negara 2.0

PENAMPANG: Festival Kepenggunaan 2025 (CONFEST 2025) yang berlangsung di ITCC. Penampang dari 11 hingga 13 Julai menjadi platform penting dalam mengumpul input bagi penggubalan Dasar Pengguna Negara 2.0 (DPN 2.0).

Festival anjuran Kementerian Perdagangan Dalam Negeri dan Kos Sara Hidup (KPDN) itu turut menjadi acara kemuncak sambutan Hari Pengguna Kebangsaan tahun ini, bertemakan 'Semarak Konsumerisme'.

Antara aktiviti utama ialah Battle of the Buskers, Sketsa Muzikal, Bicara Berirama dan Ekplorasi Troli Pintar yang melibatkan penyertaan pelajar sekolah rendah, menengah dan universiti yang telah melalui saringan awal di peringkat negeri dan zon.

"DPN 2.0 akan menjadi rujukan utama kepada semua pemegang taruh yang berkaitan dalam isu kepenggunaan, termasuk memperincikan peranan dan tanggungjawab mereka," katanya ketika merasmikan CONFEST 2025 di sini, pada Ahad.

Menurutnya, dasar itu digubal bagi menangani cabaran semasa seperti kelemahan kawal selia, pengguna kurang celik maklumat, penggunaan produk

tidak selamat, penipuan transaksi serta penyalahgunaan teknologi termasuk kecerdasan buatan (AI).

Beliau berkata, DPN 2.0 turut memberi penekanan kepada isu kos sara hidup rakyat menerusi pelaksanaan inisiatif seperti Program Payung Rahmah MADANI, peluasan **Portal** MADANI dan indikator kos sara hidup sebagai rujukan pengguna.

Bagi memperkasa penglibatan masyarakat, Armizan turut melancarkan logo Skuad Kita Pengguna (SKiP) - sebuah pasukan sukarelawan yang akan menjadi rakan strategik kementerian dalam menyampaikan advokasi kepenggunaan di seluruh negara.

KPDN menyasarkan keahlian SKiP mencecah 25,000 orang menjelang akhir tahun ini bagi memperkukuh jalinan antara kerajaan dan rakyat serta mempertingkat keberkesanan pelaksanaan DPN 2.0.

KPDN in final phase of finalising DPN 2.0 implementation

KOTA KINABALU: The Ministry of Domestic Trade and Cost of Living (KPDN) is currently in the final phase of finalising the implementation of the National Consumer Policy 2.0 (DPN 2.0), which will serve as the primary reference for all stakeholders within the consumer ecosystem.

Its Minister Datuk Armizan Ali said the policy was created to help the country better handle today's complicated challenges, like relaxed regulations, enforcement problems and low consumer awareness.

"DPN 2.0 will detail the roles and responsibilities of each stakeholder, whether directly or indirectly involved, in ensuring the effectiveness of consumer protection laws and the comprehensive delivery of information towards the development of an empowered Malaysian consumer," he said.

Armizan added that among the main challenges to be addressed through DPN 2.0 are issues of consumer exploitation, the use of unsafe or environmentally unfriendly products, fraud in purchase transactions, and the misuse of digital technologies including artificial intelligence.

"DPN 2.0 also emphasises the issue of the cost of living for the people through an inclusive and responsive policy approach.

"The related initiatives currently being implemented include the execution of the Madani Umbrella Programme, the expansion of the use of the Madani Ihsan Portal as a daily essentials price reference, and the use of the cost of living indicators as a guide for consumer spending," he said at a media conference during the Closing Ceremony of the 2025 Consumer Festival (Confest 2025) in conjunction with the National Consumer Day celebration here on Sunday.

Meanwhile, he also announced the launch of the Skuad Kita Pengguna (SKIP) logo as part of the strategy under the Kita Gempur initiative to expand community involvement in consumer advocacy.

"SKIP will serve as a strategic partner to the ministry in raising public awareness about their rights and responsibilities as consumers," he said.

According to him, the empowerment of SKIP is also driven by an increase in membership nationwide, with a target of registering 25,000 members by the end of 2025.

THE Orang Asli community has a chance to stock up on essential goods at affordable prices during a "Madani Rahmah Sale Programme" (PJRM) held at the Orang Asli One-Stop Centre (OAOSC) in Sungai Siput, Perak. Despite the distance, Long Busu, 56, a rubber tapper from Legap regroupment scheme

Legap regroupment scheme (RPS), said he drove nearly an hour to the centre to buy household items at reduced prices.

Describing it as a highly beneficial government initiative for the low-income group, the father-of-six and grandfatherof-10 said the programme organised by Domestic Trade and Cost of Living Ministry (KPDN) had significantly helped Orang Asli households, particularly those in remote

"It is quite a long journey to get here but I came because the essential items are sold at low prices.

"I bought rice, chicken and cooking oil, which are cheaper here than at the supermarkets," Long Busu told Bernama.

Supply of eggs not affected by subsidy reduction: Minister

KUALA LUMPUR: Malaysia's chicken egg supply has remained stable and sufficient despite the subsidy reduction by five sen per egg since May 1, said Agriculture and Food Security Minister Datuk Seri Mohamad Sabu.

He said this proved that the reduction has not disrupted supply. "In fact, it reflects the growing sustainability and resilience of the local production system," he said in a Facebook post yesterday.

The government had previously announced the end of egg price controls, with subsidies cut from 10 sen to five sen per egg from May and set to be fully removed next month.

The ministry had said the decision was made after considering the industry's commitment to ensuring that egg production remains sufficient. It also noted that prolonged price controls and subsidies are unsustainable for the long-term viability of local producers and the country's financial position.

Re-targetting egg subsidies is part of the government's broader effort to ensure more efficient use of public funds and promoting the sustainability of local food production. – Bernama

PETALING JAYA: Buying a used car in Malaysia can be a lifesaver or a trap. Hidden damage, tampered odometers and slick cosmetic fixes are leaving unsuspecting buyers at risk, and experts say it is time for real protection.

A national database to track used car histories is urgently needed to shield consumers from unknowingly purchasing defective vehicles, said an automotive expert.

Universiti Teknologi Malaysia Automotive Development Centre director Dr Mohd Azman Abas said the data already exists with authorities and relevant players, but Malaysia lacks a central system that allows buyers to check a vehicle's background using its registration or chassis number.

"Countries like the United States, United Kingdom and Japan already have systems to track accident history, mileage, flood damage and ownership records.

"Malaysia must move in that direction to protect its consumers."

Currently, several private platforms offer paid vehicle history reports. However, they operate independently and vary in the depth and type of information provided – making them inconsistent, costly and less accessible to the average buver.

Azman warned that buying a used car without proper checks remains a high-risk gamble.

Even vehicles that look cosmetically sound can have underlying issues.

"The real danger lies in the chassis. If it's been compromised, it can affect a car's alignment, crash safety and structural integrity. These flaws are often invisible without a thorough inspection" he said.

He added that buyers often rely on appearance and dealer promises, unaware of the long-term consequences.

"Safety components like airbags, brakes and suspension can be damaged or even removed, and many won't realise until it's too late. These systems are critical for safe driving."

"Dealers often hide behind 'as-is' clauses, shifting all responsibility to buyers – many of whom aren't fully aware of what that means."

Saravanan welcomed the Domestic Trade and Cost of Living Ministry's move to propose Lemon Law provisions, calling it long overdue. "Lemon Law isn't just about breakdowns –

temon Law isn't just about breakdowns – it's about fairness in a market that involves highvalue purchases and low accountability.

"We urge the government to push the amendment through swiftly and ensure strong enforcement so it works in practice, not just on paper."

He said such a law would set post-sale warranty standards, allow consumers to seek repairs, refunds or replacements for defective vehicles and place more responsibility on sellers.

He also highlighted the urgency as electric vehicles (EVs) become more common.

"EV faults – like battery issues or software glitches – are hard to detect and expensive to fix. Without legal protection, buyers are left exposed and public trust in EVs could be undermined."

Saravanan advised consumers to demand full documentation, avoid deals that seem too good to be true and always get a professional inspection before buying.

Over 22,000 litres of diesel seized, five arrested



KUCHING: The Sarawak General Operations Force (GOF) arrested five individuals and seized 22,730 litres of subsidised diesel in a series of raids last week.

The operations, codenamed 'Op Taring Bravo' and 'Op Taring Awas/ Batas', was conducted in Lundu and Kota Samarahan on July 9, and in Kuching on July 10.

Sarawak GOF Brigade
Commander SAC Dr Che Ghazali
Che Awang said the operations
also led to the confiscation of
various vehicles and fuel storage
equipment with the
total seizure
valued at more than RM681,000.

The detained suspects consist of five local men, aged between 26

and 34.

"The first operation took place at 7.30 am in Lundu, when the GOF 11th Battalion intercepted a Toyota Hilux — believed to be transporting diesel in excess of permitted limits without valid documentation.

"Checks uncovered 230 litres of diesel and 10 jerry cans stored in the back of the vehicle. The Toyota Hilux was also seized, bringing the estimated total seizure value to RM81.155.50." he said.

Later that day, around 1 pm, Sarawak GOF Brigade intelligence officers raided a premises in Kota Samarahan suspected of illegally storing subsidised diesel.

The team seized 18,000 litres of diesel and 17 intermediate bulk containers (IBC) at the site, along with a Toyota Hino tanker

estimated at RM218,840.

Che Ghazali added that the GOF 11th Battalion Intelligence Branch raided another premises in Kuching at 12.30 pm the next day (July 10).

"Further inspections led to the discovery of 4,500 litres of diesel, 13 IBCs, two skid tanks, 25 PVC hoses of various sizes, two fuel pump engines, and a Nissan tanker lorry. The estimated seizure value amounted to RM381,060," he said.

All the suspects and the seized items have been handed over to the Ministry of Domestic Trade and Cost of Living (KPDN) Sarawak for further investigation.

He pointed out all three cases are being investigated under Section 21 of the Control of Supplies Act 1961 and other relevant legislations.
