# KPDN batal permit!

*Penarik kereta berlagak samseng bakal diambil tindakan tegas*

**K**ementerian Perdagangan Dalam Negeri dan Kos Sarawak (KPDN) akan mengambil tindakan tegas terhadap penarik kereta yang berlagak samseng dan mengugut pengguna di lebuh raya, susulan satu kejadian tular baru-baru ini membabitkan ejen pemilikan semula (EPS) di Lebuhraya Utara-Selatan berhampiran Hentian Sebelah Pedas-Lingga.

Menurut kenyataan rasmi Bahagian Penguat Kuasa KPDN, pihaknya sudah mengenal pasti ejen yang terbabit selepas pihaknya bekerjasama dengan Polis Diraja Malaysia (PDRM) dan tindakan penguatkuaa-

saan sudah diambil.

KPDN berkata, kementerian akan membatalkan permit EPS berkenaan kerana melanggar kod etika dan peraturan sedia ada dan setiap pemegang permit perlu patuh kepada garis panduan ketat termasuk tidak menggunakan kekerasan ketika menjalankan proses pemilikan semula.

"Mengikut data, sebanyak 3,869 pemegang permit EPS yang sah sudah berdaftar di seluruh negara melalui sistem MyEPS dan mereka tertakluk kepada peraturan ketat yang ditetapkan mengikut Akta Sewa Beli 1967 (Akta 212)," kata KPDN.

Menurut KPDN, antara syarat yang perlu dipatuhi termasuklah tidak dibenarkan memasuki premis tanpa keizinan atau tanpa perintah mahkamah, wajib menunjukkan kad pengenalan dan dokumen ber-

kaitan kepada penyewa, memberi masa munasabah untuk penyewa mengeluarkan barang peribadi, melakukan dokumentasi bergambar keadaan kenderaan dan menyenaraikan inventori serta wajib membuat laporan polis dalam masa 24 jam selepas kenderaan ditarik.

"Sebarang bentuk keganasan atau ugutan semasa proses menarik kenderaan adalah satu pelanggaran serius dan boleh menyebabkan permit ditarik balik serta tindakan undang-undang dikenakan," katanya.

Selain itu, KPDN berkata, dalam tempoh 1 Januari 2022 hingga 25 Jun 2025, KPDN sudah melakukan 762 pemeriksaan ke atas ejen pemilikan semula dengan empat tindakan kes direkodkan mengikut Akta 212 dan sebanyak 27 aduan diterima sepanjang tempoh itu.

Menurut KPDN, walaupun jumlah kes tidak tinggi, pendekatan pencegahan sentiasa dipergiat, termasuk melalui kempen kesedaran pengguna agar lebih memahami hak mereka semasa berurusan dengan ejen penarik kereta.

"Kami juga menggalakkan orang ramai menyuarakan maklumat melalui inisiatif KITA GEMPUR, termasuk menerusi saluran seperti WhatsApp (019-848 8000), portal e-aduan (eaduan.kpdn.gov.my), pusat panggilan (1-800-886-800) atau aplikasi Ez ADU KPDN," kata kementerian itu.

KPDN menegaskan bahawa ejen penarik kenderaan yang gagal mematuhi syarat permit dan etika kerja boleh dikenakan tindakan pembatalan permit serta pendakwaan, mengikut peruntukan undang-undang yang berkuat kuasa.

## **App helps shoppers catch best prices**

**KUALA LUMPUR:** The Price Catcher mobile application, developed by the Domestic Trade and Cost of Living Ministry, is helping consumers compare prices of daily essentials conveniently at their fingertips.

The app enables users to plan and manage their daily expenses by comparing prices of essential items across various supermarkets and selected retail premises nationwide.

A check by Bernama at several supermarkets around the federal capital found the prices displayed on Price Catcher to be consistent with actual prices at the premises, proving the app's reliability.

However, slight price variations were observed at certain wet markets, especially in the evenings, as some traders lowered prices to clear out perishable stock.

A user, Zaid Zufri, 42, said the app has been useful in helping him plan his daily spending.

"Before coming here, I checked the price of eggs and found a tray being sold for RM12.60 the same price shown in the app. Imported onions were just RM2.90 per kg, which is cheaper compared to other places," he said at a supermarket in Taman Maluri.

For housewife Syahida Ariffin, 45, the app is especially helpful in tracking the prices of controlled items such as cooking oil and chicken, which tend to fluctuate.

"Price Catcher shows the lowest prices at nearby supermarkets and wet markets. I always check the app first before deciding where to shop, and I can save between RM15 and RM30 each time," she said.

Launched in March 2019, Price Catcher currently displays the prices of 480 selected items, which are monitored regularly by KPDN at various premises, including wet markets, hypermarkets, mini markets and grocery stores.

## 'Price Catcher' mudahkan pengguna banding harga, rancang perbelanjaan

**KUALA LUMPUR:** Pengguna tidak perlu lagi pening kepala mencari barang keperluan pada harga berpututan kerana mereka kini boleh membuat perbandingan harga dengan mudah menerusi aplikasi 'Price Catcher' yang dibangunkan oleh Kementerian Perdagangan Dalam Negeri dan Kos Sara Hidup (KPDN).

Aplikasi berkenaan dilihat mampu menjadi 'pembantu peribadi' dalam merancang dan mengawal perbelanjaan harian, dengan membolehkan pengguna membandingkan harga barang keperluan di pelbagai pasar raya dan premis terpilih di seluruh negara.

Tinjauan Bernama di beberapa pasar raya sekitar ibu negara mendapati harga barang yang dipaparkan menerusi aplikasi 'Price Catcher' adalah konsisten dengan harga sebenar di premis berkenaan, sekali gus membuktikan kebolehpercayaannya.

Namun, di beberapa pasar basah, terdapat sedikit perbezaan harga terutama pada waktu petang berikutnya segelintir peniaga menurunkan harga bagi menghabiskan stok.

Secara keseluruhan, aplikasi itu dilihat memberi manfaat besar kepada pengguna yang mahu berjimat dalam keadaan kos sara hidup yang mencabar, walaupun masih ramai belum mengetahui kewujudannya.

Zaid Zufri, 42, seorang daripada pengguna 'Price Catcher' mengakui aplikasi itu amat membantu dalam merancang perbelanjaan harian bagi mendapatkan penjimatan yang lebih berkesan.

"Sebelum saya ke sini, saya semak dahulu harga telur dan dapat satu papan dijual pada RM12.60, sama seperti harga di aplikasi. Bawang besar import pula cuma RM2.90

sekilogram, lebih murah berbanding tempat-tempat lain," katanya ketika ditemui di pasar rayad di Taman Maluri dekat sini.

Bagi suri rumah, Syahida Ariffin, 45, aplikasi itu amat membantu terutama ketika mencari barang kawanan seperti minyak masak dan ayam yang sering berubah-ubah harganya.

"Aplikasi 'Price Catcher' paparkan harga terendah di pasar raya dan pasar basah berhampiran. Jadi, saya buat semakan melalui aplikasi ini dahulu sebelum pilih pasar raya yang tawarkan harga lebih murah, dapat jimat antara RM15 hingga RM30 bagi setiap pembelian," katanya.

Bagaimanapun, tinjauan turut mendapati masih ramai pengguna yang tidak menyedari kewujudan aplikasi berkenaan termasuk Fadilah Fauzi, 30, yang mengakui beliau hanya membeli barang keperluan di pasar raya berhampiran tanpa ambil peduli soal perbandingan harga.

"... tapi bila dah tahu pasal aplikasi ini, saya berminat juga untuk guna bagi menjimatkan perbelanjaan," katanya.

Pekerja swasta, Mohd Ashraf Zamri, 35, pula mengakui faktor kesibukan menyebabkan beliau tidak pernah membuat semakan harga sebelum membeli.

"Saya beli ayam standard ini pada harga RM10 sekilogram, tapi bila semak guna aplikasi ini rupa-rupanya ada tempat yang tawarkan harga lebih murah," katanya yang memuat naik aplikasi berkenaan selepas ditunjukkan oleh pemberita.

Dilancarkan pada Mac 2019, 'Price Catcher' kini memaparkan harga 480 barang terpilih yang dipantau secara berkala oleh KPDN di pelbagai premis termasuk pasar basah, pasar raya besar, pasar mini dan kedai runcit. — Bernama

Dalam pada itu, Pengarah KPDN Negeri Melaka, Dr Mohd Hazimin Jamaludin berkata, usaha memperkasa ilmu kepenggunaan akan terus dipergiat melibatkan sekolah, universiti dan gerakan pengguna seluruh negeri.

# Syarikat umrah, pengarah didakwa gagal bayar tuntutan RM232,526.80

**Kota Kinabalu:** Sebuah syarikat yang menawarkan pakej umrah dan pengarahanya, didakwa di Mahkamah Majistret, di sini, semalam kerana gagal mematuhi keputusan Tribunal Tuntutan Pengguna Malaysia yang memerintahkan pembayaran tuntutan berjumlah RM232,526.80 kepada enam individu.

Syarikat berkenaan, Emraz Travel & Tours Sdn Bhd dan pengarahanya, Datuk Zulkarnain Endut, 44, masing-masing menghadapi enam pertuduhan mengikut Seksyen 117(1) Akta Perlindungan Pengguna 1999, yang memperuntuk hukuman denda sehingga RM10,000, penjara dua tahun atau kedua-duanya sekali jika sabit kesalahan.

Zulkarnain sebagai pengarah dan bagi pihak syarikat, mengaku tidak bersalah selepas pertuduhan dibacakan di hadapan Majistret Dzul Elmy Yunus.

Berdasarkan kertas pertuduhan, syarikat itu dan Zulkarnain melakukan kesalahan terbabit di antara Julai 2023 hingga Januari 2024 di Kementerian Perdagangan Dalam Negeri dan Kos Sara Hidup Sabah, Kompleks Pentadbiran Kerajaan Persekutuan, Jalan UMS.

Syarikat terbabit dan Zulkarnain gagal mem-

bayar tuntutan kepada enam individu, membabitkan jumlah tuntutan antara RM24,666.80 hingga RM50,000 dengan keseluruhannya berjumlah RM232,526.80.

Mahkamah menetapkan 23 September ini untuk pengurusan kes sebelum perbicaraan dan membenarkan jaminan sebanyak RM1,000 bagi setiap pertuduhan, dengan seorang penjamin tempatan.

Syarat tambahan turut dikenakan, iaitu tertuduh perlu melaporkan diri di pejabat KPDN Putrajaya pada setiap 17 hari bulan.

Fails to heed six Consumer Tribunal awards

## Umrah packages: Firm hauled up

KOTA KINABALU: A company offering Umrah packages and its director were charged in the Magistrates' Court here on Tuesday with failing to comply with six Consumer Claims Tribunal awards ordering them to pay RM232,536.80 to six individuals.

Emraz Travel & Tours Sdn Bhd, represented by its Director Datuk Zulkarnain Endut, 44, and Zulkarnain, in his capacity as a director, pleaded not guilty before Magistrate Dzul Elmy Yunus after the charges were read out.

The company and Zulkarnain, were each slapped with six counts under Section 117(1) of the Consumer Protection Act 1999, which carries a fine of up to RM10,000, a jail term of up to two years, or both, on conviction.

The charges stated that the company and Zulkarnain were alleged to have failed to comply with the award of the Consumer Claims Tribunal, which required them to pay claims to six claimants, ranging from RM24,666.80 to RM50,000, totalling RM232,536.80.

The offences were allegedly committed at the Sabah Domestic Trade and Cost of Living Ministry, Federal Government Administrative Complex, Jalan UMS, here, between July 24, 2023 and Jan 25, 2024.

They were accused of failing to pay RM24,666.80 to Mahmuddin Purag (order dated July 17, 2024); RM27,870 to Marian



Tarin (June 26, 2023); RM30,000 to Muhibdin Ismail (Sept 9, 2023); and RM50,000 each to Jamilah Othman, Nur Aimi Nazihah Norjain and Norjain Nudin, all three awards dated Nov 21, 2023.

The Magistrate set Sept 23 for pre-trial case management (PTCM) and granted bail of RM1,000 with one local surety for each charge, with the additional condition that Zulkarnain report to the Domestic Trade and Cost of Living Department office in Putrajaya on the 17th of every month.

Deputy Public Prosecutors (DPP) of Domestic Trade and Cost of Living Ministry, Shafiq Mahadi and Md Syafique Md Hilmie prosecuted while the company and Zulkarnain were represented by counsel

DPP Shafiq submitted that the case involved public interest, as it concerned numerous Umrah pilgrims who were unable to perform their pilgrimage and had suffered losses amounting to hun-

dreds of thousands of ringgit.

On that basis, the prosecution offered bail to Zulkarnain at RM2,000 with one local surety for each charge against him.

DPP Shafiq also applied for PTCM date to be fixed two months from Tuesday, as well as for mention to update the court on the status of Zulkarnain's wife, who is the third accused in the present case.

The update concerns when she would be fit to travel to Sabah to face the charges against her, as she is currently in the 11th week of a high-risk pregnancy.

Earlier, Farah applied for the warrant of arrest issued against the third accused, Datin Mazuin Mustafa, who is also a director of the company and Zulkarnain's wife, to be revoked.

She informed the court that Mazuin was unable to travel due to her high-risk pregnancy, which is her first, as confirmed in a medical report from Hospital Putrajaya dated June 20 this year.

Farah also requested a lower bail amount for Zulkarnain, citing that he is a Malaysian from Terengganu, is married, and currently has no fixed source of income.

She further informed the court that his company, Emraz Travel & Tours Sdn Bhd, had been wound up since July 17, 2024, and that its bank account had also been frozen under the Anti-Money Laundering Act (AMLA).

She also said that Zulkarnain is facing multiple similar charges across Malaysia, including in Sarawak, Sabah and Peninsular Malaysia.

# Company, director claim trial over unpaid refunds

**KOTA KINABALU:** A travel company and its director pleaded not guilty at a Magistrate's Court here on Tuesday to six charges of failing to comply with Consumer Claims Tribunal (TTPM) orders to refund a total of RM232,526.80 to six individuals.

Emraz Travel & Tours Sdn Bhd and its director, Datuk Zulkarnain Endut, 44, claimed trial before magistrate Dzul Elmy Yunus. Both were granted bail of RM1,000 with one local surety for each charge.

Zulkarnain entered the pleas on behalf of himself and the company. He was represented by counsel Farah Nazriah Chun Lee @ Mohd Fadzlee Lee, while Deputy Public Prosecutors Shafiq Mahadi and Md Syafique Md Helmie appeared for the Ministry of Domestic Trade and Cost of Living (KPDN).



face six charges under Section 117(1) of the Consumer Protection Act 1999 for failing to comply with TTPM award orders. If convicted, they face a fine of up to RM10,000, imprisonment of up to two years, or both.

According to the charges, they allegedly failed to pay the awarded claims — ranging from RM24,666.80 to RM50,000 — between 24 July 2023 and 25 January 2024 at the KPDN Sabah office, Federal Government Administrative Complex, Jalan UMS.



## Around The Courts

The third accused, Datin Mazuin Mustafa — Zulkarnain's wife and also a company director — was absent due to a high-risk pregnancy, supported by a medical report from Putrajaya Hospital dated 20 June 2025.

Her lawyer informed the court that this is her first pregnancy and is into the 11th week, with travel deemed unsafe.

Counsel Farah Nazriah requested that the arrest warrant against Mazuin be revoked, to which the prosecution had no objection.

Deputy Public Prosecutor Shafiq requested that a pre-trial case management (PTCM) be scheduled in two months and that the court be updated

on Mazuin's ability to attend. He noted the case is of public interest due to its connection with multiple Umrah packages and substantial financial losses.

He also proposed bail at RM2,000 per charge with one local surety, along with a condition for the accused to report to KPDN on the 17th of every month.

Farah Nazriah appealed for minimal bail, citing that the accused is a Malaysian citizen with no fixed income following the company's winding-up on 17 July 2024. She also highlighted the accused's personal responsibilities, including his wife's medical condition.

The accused are facing other charges throughout Malaysia, including in Sabah, Sarawak and Peninsular Malaysia.

The court fixed 23 September 2025 for pre-trial case management and maintained bail at RM1,000 per charge with one local surety.

# Sindiket penjualan baja secara haram di kawasan elit tumpas

**MELAKA:** Kegiatan membungkus dan mengedara baja kawalan secara haram yang dijalankan di kawasan perumahan elit di negeri ini tumpas hasil serbuan Kementerian Perdagangan Dalam Negeri dan Kos Sarawak Hidup (KPDN) Melaka, semalam.

Operasi hasil risikan selama seminggu itu berjaya membongkar tindakan sindiket menyewa tiga buah rumah banglo mewah di kawasan berpagar untuk dijadikan ‘kilang’ membungkus semula baja sebelum diedarkan ke seluruh negara.

Pengarah KPDN Melaka, Dr. Hazimin Jamaludin berkata, kegiatan itu dikesan hasil aduan masyarakat dan berjaya dihidu menerusi Ops Samar yang digerakkan secara agresif di seluruh negeri.

Hasil siasatan mendapati sindiket berkenaan menyewa rumah banglo di kawasan elit yang kawalannya sangat ketat, menyebabkan ia sukar dikesan.

“Sebanyak 4.1 tan baja dianggarkan bernilai RM6,789 dirampas dan dipercayai telah dijual

secara dalam talian terutama menerusi TikTok.

“Kami mendapati alat timbang digunakan tidak ditentusahkan, selain baja itu dibungkus semula menggunakan sukaan tidak tepat, sekali gus menyalahi undang-undang,” katanya selepas

mengetua operasi berkenaan.

Siasatan awal mendapati kesemua baja dibeli dari tempat lain yang kemudian dibungkus semula dalam kuantiti kecil dan dijual semula dengan keuntungan berlipat ganda hingga RM400,000 sebulan.

## Man fined RM55,000 for possessing 10,400 litres of diesel without permit

**KUCHING:** The Sessions Court here yesterday fined a man RM55,000 in default six months' imprisonment after he pleaded guilty to unlawful possession of 10,400 litres of diesel.

Judge Zuraidah Zakaria handed down the sentence on Mark Cliffon Song Choon Hua, 25, and ordered that the proceeds from the sale of the fuel, totalling RM22,672, be forfeited to the government.

Mark was charged under Section 21 of the Control of Supplies Act 1961, punishable under Section 22(1) of the same

Act, with possessing the diesel without a licence or permit at a warehouse on Jalan Stampin at around 11am on June 27, 2024.

Based on the facts of the case, an enforcement team raided the warehouse and discovered a lorry, 30 intermediate bulk containers (IBC), three large hoses, and three electric pumps.

Upon inspecting the vehicle and IBC tanks, the team uncovered 10,400 litres of diesel, which is a scheduled controlled item under the Control of Supplies Act 1961. The accused, who was present at the warehouse, was detained for

investigation.

Investigations determined that the fuel belonged to the accused; however, records from the Ministry of Domestic Trade and Cost of Living showed no licence or permit had been issued in the name of the accused to handle scheduled controlled goods.

It was also discovered that the seized diesel had been purchased from petrol stations around Kuching.

Deputy public prosecutor Iezzah Iburdanisha Ibrahim handled the prosecution, while the accused was unrepresented.

## Lelaki mengaku bersalah simpan 10,400 liter minyak diesel tanpa lesen

**KUCHING:** Seorang lelaki dijatuhi hukuman denda RM55,000 atau enam bulan penjara oleh Mahkamah Sesyen di sini, semalam selepas mengaku bersalah menyimpan 10,400 liter minyak diesel tanpa lesen.

Hakim Zuraidah Zakaria menjatuhkan hukuman itu terhadap Mark Cliffon Song Choon Hua, 25, dan memutuskan agar hasil jualan minyak diesel sebanyak RM22,672 dirampas dan dilucut hak untuk dijadikan hasil kerajaan.

Tertuduh didakwa mengikut Seksyen 21 Akta Kawalan Bekalan 1961 dan boleh dihukum di bawah Seksyen 22(1) Akta Kawalan Bekalan 1961.

Fakta kes mendedahkan pada 27 Jun 2024, lebih kurang jam 11.00 pagi, sepasukan penguat kuasa telah melakukan serbuan ke sebuah gudang di Jalan Stampin, Batu 7 di sini.

Semasa serbuan, pasukan menemui sebuah lori, 30 unit tangki Intermediate Bulk Container (IBC), tiga unit hos bersaiz besar dan tiga unit pam elektrik.

Selepas melakukan periksaan terhadap kenderaan berkenaan dan tangki IBC, pasukan penguat kuasa menjumpai 10,400 liter minyak diesel yang merupakan barang kawalan berjadual di bawah Akta Kawalan Bekalan 1961.

Selain merampas kesemua barang tersebut, pasukan turut menahan tertuduh

yang berada di kawasan berkenaan untuk siasatan dan tindakan lanjut.

Hasil siasatan mendapat minyak diesel yang merupakan barang kawalan dan disimpan di dalam tangki IBC di lokasi kejadian adalah milik tertuduh.

Bagaimanapun, berdasarkan pengesahan dan rekod Kementerian Perdagangan Dalam Negeri dan Kos Sarawak Hidup, didapati tiada sebarang lesen atau permit barang kawalan berjadual dikeluarkan atas nama tertuduh.

Siasatan lanjut juga mendapat minyak diesel yang dirampas tersebut dibeli dari stesen-stesen minyak di kawasan Kuching bagi tujuan melakukan kesalahan.

Sehubungan itu, tertuduh melakukan kesalahan di bawah Seksyen 21 Akta Kawalan Bekalan 1961 iaitu memiliki barang kawalan berjadual dalam keadaan yang menimbulkan syak munasabah bahawa satu kesalahan telah dilakukan di bawah Peraturan 3(1) Peraturan-Peraturan Kawalan Bekalan (PPKB) 1974.

Peraturan tersebut merujuk kepada kesalahan berurusan dengan barang kawalan berjadual tanpa lesen yang sah daripada Pengawal Bekalan dan kesalahan ini boleh dihukum di bawah Seksyen 22(1) Akta Kawalan Bekalan 1961.

Pendakwaan dilakukan oleh Timbalan Pendakwa Raya Iezzah Iburdanisha Ibrahim sementara tertuduh tidak diwakili peguam.

# Plan B if pharmas hike prices

Tariff threat may be minimal but alternative sources needed

PETALING JAYA: US President Donald Trump has threatened to impose a 200% tariff on pharmaceutical imports into the United States, and while global pharma giants are awaiting further developments, stakeholders anticipate a minimal impact on Malaysia at this juncture.

While Malaysia is facing 25% tariffs on various exports to the US, the impact from this industry remains uncertain, leaving the government, particularly the Health Ministry, sourcing for alternatives to mitigate the supply chain.

According to research from Pharmaceutical Research and Manufacturers of America (PhRMA), it is estimated that a tariff of 25% on pharmaceutical imports would drive up US drug prices by almost RM217bil (US\$51bil) annually, increasing domestic prices by as much as 12.9% if passed on.

The group called out Trump's proposal as counterproductive to health outcomes.

With this scenario looming, Malaysian Pharmacists Society (MPS) president Prof Amrahi Buang stressed on the urgent need for the government to take proactive measures by initiating direct negotiations with pharmaceutical companies to reduce prices.

"This issue pertains to medicine security, and it is certain that geopolitics will influence trade and the availability of patented drugs from the US for our patients."

"However, government procurement has a specific method to handle this under Treasury Instructions."

"Under Prime Minister Datuk Seri Anwar Ibrahim, Malaysia has

established numerous connections with non-US markets in the region, including Asean, China, Japan, Europe, and BRICS.

"Since we import 60% of our medicines, various efforts have been made to increase local production. If we can cut wastage with better medicine adherence, this is applaudable too," he said.

"The Treasury Instructions are financial regulations and accounting procedures issued by the Treasury Department to manage government finances, which are binding on all accounting officers of the Federation and the states.

"It covers various aspects of financial management, including budget, revenue, expenses, earnings and public assets," added Amrahi.

Pharmariaga Berhad managing director Zulkifli Jafar said the local pharmaceutical giant does not engage in direct exports with the United States; thus, it does not anticipate any immediate impact on its operations.

"Nevertheless, we recognise that global trade is deeply interconnected, where developments in one region can have cascading effects on supply chains worldwide.

"We will closely monitor the situation and maintain active engagement with our local and

international suppliers to assess potential risks and align on appropriate contingency plans.

"This proactive approach ensures we are prepared to respond swiftly, should the need arise. Our priority remains clear: to always ensure uninterrupted delivery of our products and services to customers," he added.

Association of Private Hospitals Malaysia (APHM) President Datuk Dr Kuljit Singh said Trump's proposed 200% tariff on foreign-made medicines may have indirect effects on the healthcare sector, due to the deeply interconnected nature of global pharmaceutical supply chains.

"We expect the immediate shock to Malaysia to be minimal, as, unlike the US, Malaysia has a healthy generics and Active Pharmaceutical Ingredients (API) ecosystem, and we tend to rely on well-established, essential medicines rather than newer, high-cost therapies targeted to Western markets.

"Furthermore, the global supply chain is already segmented geographically due to pricing and market strategies, and Malaysia's role in that system is unlikely to be seriously disrupted," he said.

However, Dr Kuljit said if tariffs lead to increased pressure on major exporters like India, China,

and the European Union to prioritise US-bound shipments in the next 18-month grace period, it could lead to price increases or delays for essential medicines in secondary markets like Malaysia for categories such as antibiotics, chronic disease medications, and certain vaccines.

"These impacts would only materialise if the policy was fully implemented and sustained over time. To date, many of Trump's tariff threats across sectors like steel, auto and now pharmaceuticals have generated short-term international concern, but often with limited long-term follow-through," he said.

"For long-term resilience, it would be helpful for Malaysia to look into diversifying suppliers and investing in local pharmaceutical production.

"We should monitor the situation but not panic, as although the proposed tariff may rattle global markets, Malaysia is relatively well-positioned to manage the impact," he added.

Malaysian Community Pharmacy Guild (MCPG) president Sarah Abdullah said the tariffs may not have significant impacts on medicine prices, adding that the escalation of wars and geopolitical conflict would be a reason to be more concerned about, as that would disrupt the supply chain.

As for generic medicines, she said local manufacturers will not be impacted in sourcing raw materials.

"Possibly, there might be higher demand. It depends; if the branded companies increase their prices, then maybe patients will opt to go for generic medicine, which is okay because they are of good quality and also abide by Good Manufacturing Practices standards," she said.

## Lari 2km elak ditahan memandu tanpa lesen

**Kuala Terengganu:** Cubaan seorang lelaki Rohingya mlarikan diri sejauh kira-kira dua kilometer selepas didapati memandu tanpa lesen gagal apabila dia berjaya ditahan dalam satu operasi bersepadu semalam.

Lelaki berusia 35 tahun dan pemegang kad Suruhanjaya Tinggi Bangsa-Bangsa Bersatu bagi Pelarian (UNHCR) itu memecut kereta dipandunya selepas tersempak dengan pegawai Jabatan Imigresen Malaysia (JIM) negeri.

Bagaimanapun, cubaan lelaki itu gagal apabila kereta dipandunya dipintas kenderaan pegawai JIM yang mengekorinya.

Ketika soal siasat dilakukan, lelaki itu mengaku memandu kereta untuk menghantar dan mengambil penumpang daripada kalangan warga asing sejak 1998.

Pengarah JIM negeri, Mohd Yusri Mohd Nor berkata, kereta itu diserahkan kepada Jabatan Pengangkutan Jalan (JPJ) untuk tindakan selanjutnya.

Katanya, seramai 120 warga asing dan penduduk tempatan diperiksa dalam Op Bersepadu selama tiga jam bermula kira-kira 10 pagi.

"Kita melakukan serbuan dan pemeriksaan ke atas 12 premis perniagaan termasuk sebuah kilang batu di sekitar Kuala Nerus dan Kuala Terengganu," katanya.

Daripada jumlah itu, katanya, seramai 11 warga asing termasuk seorang wanita Indonesia

berusia 37 tahun ditahan kerana memasuki negara tanpa kebenaran.

"Wanita warga Indonesia ditahan di sebuah kedai runcit di daerah Kuala Nerus dan disiasat mengikut Seksyen 6(1) (c), Akta Imigresen 1959/63, kerana memasuki negara tanpa pas atau permit sah," katanya.

Terdahulu, Mohd Yusri mengetuai Op Bersepadu membabitkan Majlis Keselamatan Negara (MKN), Polis Diraja Malaysia (PDRM), Kementerian Perdagangan Dalam Negeri dan Kos Sarawak Hidup (KPDN) serta Majlis Bandaraya Kuala Terengganu (MBKT).

Mengulas lanjut, Mohd Yusri berkata, warga asing yang ditahan adalah tiga lelaki Myanmar dan tujuh lelaki Bangladesh berusia antara 20 dan 40 tahun.

"MBKT juga mengeluarkan kompaun atas kesalahan tidak memiliki lesen perniagaan dan premis kotor.

"KPDN juga turut mengeluarkan saman atas kesalahan timbang dan sukat serta akta pengaturan," katanya.
