Penyeludup guna kenderaan pendaftaran Malaysia beli diesel

Alor Setar: Kementerian Perdagangan Dalam Negeri dan Kos Sarra Hidup (KPDN) mengesahkan taktik licik penyeludup warga asing mempunyai menggunakan nombor pendaftaran negara ini pada kenderaan untuk membeli minyak diesel.

Pengarah KPDN Kedah, Muhammad Nizam Jamaludin berkata, kegiatan itu dikesan di Kuala Nerang pada 16 Ogos lalu hasil aduan awam dan risikan penguatan kuasa KPDN Alor Setar.

Katanya, sebuah trak pikap sedang mengisi diesel di stesen minyak berkenaan dan kemudian bergerak ke bahagian belakang premis itu.

"Pemantauan mendapati pemilik kenderaan itu bertindak licik dengan

menukarkan nombor pendaftaran tempatan yang disyaki palsu itu kepada nombor pendaftaran asal kenderaan berkenaan iaitu nombor pendaftaran asing selepas mengisi minyak di stesen berkenaan.

"Penguat kuasa menyerbu kenderaan itu dan pemeriksaan menemukan diesel yang disimpan dalam tangki ubah suai.

"Seorang wanita warga negara Thailand berusia 40-an yang memandu

kenderaan pikap itu ditahan untuk siasatan lanjut," katanya dalam satu kenyataan semalam.

Muhammad Nizam berkata, pemeriksaan susulan terhadap stesen minyak berkenaan dan berdasarkan cetakan resit jualan mendapati stesen minyak itu menjual 273 liter diesel dalam satu transaksi kepada kenderaan itu.

Beliau berkata, ia sekali gus melanggar arahan pengawal bekalan berhu-

bung had penjualan kepada kenderaan berpendaftaran tempatan dalam satu hari.

Katanya, kes disiasat mengikut Akta Kawalan Bekalan 1961 dan mana-mana orang jika disabitkan kesalahan boleh didenda tidak melebihi RM1 juta untuk individu atau penjara selama tiga tahun atau kedua-duanya.

Beliau berkata, bagi kesalahan kedua dan berikutnya, denda tidak melebihi RM3 juta atau penjara tidak melebihi lima tahun atau kedua-duanya.

"Bagi kesalahan syarikat pula boleh didenda tidak melebihi RM2 juta manakala bagi kesalahan kedua dan berikutnya, denda tidak melebihi RM5 juta," katanya.

Tipu nombor plat kenderaan beli diesel, wanita Thailand ditahan

PADANG TERAP - Taktik licik seorang wanita warga Thailand yang menggunakan nombor pendaftaran kenderaan Malaysia demi mendapatkan minyak diesel bersubsidi terbongkar selepas diserbu oleh pasukan penguat kuasa Kementerian Perdagangan Dalam Negeri dan Kos Sarawak Hidup (KPDN) di Kuala Nerang.

Dalam kejadian pada Sabtu, wanita berusia lingkungan 40-an itu dikesan memandu sebuah pikap jenis Isuzu D-Max yang menggunakan nombor pendaftaran tempatan palsu ketika mengisi diesel di sebuah stesen minyak di sini.

Menurut Pengarah KPDN Kedah, Muhammad Nizam Jamaludin, hasil risikan dan aduan awam membawa kepada pemantauan rapi sebelum pasukan serbu bertindak menahan kenderaan terbabit.

"Selepas selesai mengisi minyak, kenderaan itu dilihat bergerak ke bahagian belakang stesen dan menukar semula nombor pendaftaran kepada nombor asal berdaftar di Thailand," katanya dalam satu kenyataan pada Isnin.

Pemeriksaan lanjut mendapatkani kenderaan tersebut telah diubah suai dengan tangki khas untuk menyimpan diesel dalam jumlah besar.

Sebanyak 273 liter minyak disyaki diesel berjaya disita dengan nilai RM791.73 bersama resit pembelian dan dokumen perniagaan.

Turut disita ialah kenderaan pikap terbabi dengan nilai keseluruhan sataan dianggarkan berjumlah RM30,791.73.

Muhammad Nizam berkata, siasatan turut dijalankan terhadap stesen minyak berkenaan selepas didapati menjual diesel melebihi had yang dibenarkan dalam satu transaksi, sekali gus melanggar Arah Pengawal Bekalan.

IP ecosystem that not only protects creators but also fosters innovation and safe-guards public interest," she added.

She emphasised that MyIPO's long-term vision is to establish a forward-looking legal framework that maintains robust intellectual property rights in the era of AI, thereby ensuring Malaysia's competitiveness in the global innovation economy.

The conference, themed "Owning the Future – IP in the Age of AI", brought together policymakers, legal experts, researchers, academics, industry leaders, and other stakeholders to examine how AI is reshaping intellectual property protection both domestically and internationally.

Discussions centred on pressing issues, including the recognition of machine-generated works, the role of AI in patent and design creation, and the continued protection of human works in a rapidly evolving technological environment.

The dialogue also served as a platform to bridge the gap between existing laws and emerging technologies, laying the groundwork for resilient IP policies that can withstand fast-paced change.

For the wider public, the outcomes of the dialogue are expected to influence how people create, trade, and use digital content.

Whether as designers, writers, entrepreneurs, or consumers, the policy directions shaped through this initiative will determine how intellectual property rights and protections for creative works and innovations are upheld in the future.

Globally, AI and IP have become central policy concerns.

The World Intellectual Property Organization (Wipo), through its Wipo Conversation series, has convened stakeholders worldwide to examine opportunities and challenges arising from AI.

While some countries are considering legal recognition of AI-generated works, others insist that IP protection should remain grounded in human contribution.

MyIPO pushes for stronger IP framework amid AI challenges

KUALA LUMPUR: The Intellectual Property Corporation of Malaysia (MyIPO) is intensifying its efforts to shape future policies and legislation that address the growing challenges posed by artificial intelligence (AI) in the intellectual property landscape.

MyIPO said its priority, as the custodian of intellectual property rights in Malaysia, is to strike a balance between protecting the rights of creators and safeguarding public interest, while ensuring that the country's IP framework remains progressive, resilient, and aligned with global technological developments.

MyIPO deputy director general (operations) Yusnieza Syarmila Yusoff said the rapid adoption of AI has raised new questions about ownership and accountability in the creative and innovation space.

"Currently, IP laws recognise human creators through protection under copyright, patents, trademarks, and related rights.

"However, with the increasing use of AI in generating content, inventions, and designs, the critical issue is determining who owns the rights when a creation is produced entirely by a machine.

"Without clear ownership, it becomes difficult to take legal action in cases of infringement," she said at the National Dialogue on Intellectual Property and Artificial Intelligence yesterday.

Yusnieza said this challenge has prompted MyIPO to initiate broader discussions on how Malaysia's IP legislation can evolve to remain relevant.

"The aim is to assess whether current laws are sufficiently comprehensive, and to consider whether new provisions, exceptions, or limitations are required – particularly concerning fair use and digital applications of IP.

"By driving national dialogue and engaging with industry players, academics, and policymakers, MyIPO seeks to build an
