Solution to Koiduan crossing soon

PAPAR: The government will look for the best solution to rebuild a new low-level crossing (LLC) at Kg Kaiduan, here, which collapsed last Saturday after being swept away by strong river currents following recent incessant heavy rain.

Papar Member of Parliament, Datuk Armizan Mohd Ali said a site inspection would be carried out together with technical agencies to identify the most suitable approach, taking into account the extreme conditions in the area.

He said discussions with District Natural Disaster Committee (JBPD) with State Natural Disaster Committee (JPBN) led by State Secretary have been carried out to look for best solution to address problems including infrastructures especially in Kg Kaiduan and Kg Bisuang.

"Although an LLC was previously built, it could not be used when the water river rose and overflowed, except during dry spells or when the current was low.

"We need specifications and a design that can withstand the extreme conditions here because even on normal days the river current is already strong, let alone during heavy rain as we are experiencing now.

"Therefore, the state and federal governments are committed to finding a solution for this immediately," Armizan who is also Domestic Trade and Cost of Living Minister, said.

Kg Kaiduan has been adopted by Ministry of Domestic Trade and Cost of Living (KPDN) several months ago which will make sure the village is equipped with necessary infrastructures that could cater the needs of the villagers.

"In fact, the LLC had already collapsed on Sept 13. Since the onset of continuous heavy rain, the situation has been extreme for nearly 10 days, but in the past two days we received reports of particularly severe challenges at the site.

"On Sept 13, during extremely heavy rainfall, the strong current caused the LLC to collapse due to a combination of factors — the force of the water, debris clogging the culverts, and erosion of the LLC's foundation structures at both ends," he said.

Armizan said villagers in the LLC area still have an alternative route, although not by

road where they can use a suspension bridge to cross.

On the flood situation, he said ensuring food supplies to affected residents who are the victims remain the top priority of the Papar District Disaster Management Committee.

He said the relocation of residents to existing PPS facilities, particularly those whose homes are at risk of flooding, must be carried out immediately.

"Eighteen roads have been cut off, 12 of them due to floods, while the rest were caused by landslides, preventing access to the affected villages.

"So far, four roads have been reopened, but several others remain inaccessible, making it urgent for food supplies to be delivered quickly," he said.

Armizan expressed his condolences following two fatal landslides in Sabah that claimed five lives, including a mother and her child in Kampung Mook, and three individuals in Kampung Marahang Tuntul on Monday (Sept 15).

He announced that temporary housing and financial assistance would be provided to affected families, in addition to the RM10,000 cash aid earlier announced by

Chief Minister Datuk Seri Hajiji Noor.

"The families have been temporarily relocated to community halls in Kampung Mook and Kampung Marahang while we assess the risk at their original homes. Discussions will be held to move them into nearby People's Housing Programme (PPR) units or rental homes," he said.

Armizan also urged residents living near hillsides or slopes to evacuate early in the event of heavy rain, especially during the current monsoon season.

"Unlike in Peninsular Malaysia, many in Sabah reside near high-risk areas like hillsides. This greatly increases the danger during heavy rainfall," he said.

"Don't wait until the last minute. Move to your relatives' homes or the nearest temporary evacuation centre (PPS). Also, ensure your valuables and important documents are secured or taken with you."

As of September 16, a total of 215 individuals from 63 families had been evacuated to three PPS centres in the district due to floods and landslides.

Of these, 116 flood victims are currently housed at the Papar Community Hall, 77 at Lokkawi Heights PPS, and 22 at the Kampung Mook Kinarut Community Hall.

154 syarikat mendaftar pada hari pertama pendaftaran subsidi RON95

PAPAR: Pendaftaran subsidi RON95 yang dibuka pada 15 September lalu susulan pelaksanaan penyasaran RON95 yang bakal dilaksanakan Kerajaan menyaksikan sebanyak 154 syarikat telah membuat pendaftaran di Sistem Kawalan Petrol Bersubsidi (SKPS).

Menteri Perdagangan Dalam Negeri dan Kos Sara Hidup (KPDN) Datuk Armizan Mohd Ali berkata pendaftaran itu melibatkan sebanyak 335 kenderaan di bawah dua kategori ditetapkan SKPS.

Daripada jumlah itu katanya, sebanyak 70 syarikat mendaftar di bawah kluster Pengangkutan Awam Darat melibatkan 240 buah kenderaan dan 84 syarikat di bawah kluster Pengangkutan Darat

Barangan dengan 95 buah kenderaan.

"Semuanya mendapat kelulusan serta merta selepas menyediakan dokumen lengkap dan kini mereka hanya perlu masuk peringkat kedua iaitu memohon 'fleet card' daripada syarikat-syarikat minyak pilihan mereka.

"Hanya tiga syarikat saja boleh dipilih untuk mendapatkan 'Fleet Card' ini, walaupun semua syarikat minyak telah pun mengesahkan komitmen mereka untuk mengeluarkan kad itu kepada pemohon dengan segera.

"Kelancaran urusan ini berdasarkan pengalaman kita semasa melaksanakan Sistem Kawalan Diesel Bersubsidi (SKDS) tahun lalu (di Semenanjung saja)," katanya

ketika ditemui selepas lawatan ke Pusat Penempatan Sementara (PPS) Lok Kawi Heights, di sini, baru-baru ini.

Armizan berkata KPDN menyasarkan sebanyak 100,000 kenderaan seluruh negara didaftar di bawah SKPS yang telah diintegrasikan dengan sistem data Jabatan Pengangkutan Jalan (JPJ).

Sehubungan itu katanya, pihaknya berharap jumlah pendaftaran kenderaan itu terus meningkat di hari seterusnya bagi memastikan semua syarikat layak mendapat subsidi selepas penyasaran RON95 itu dilaksanakan kerajaan.

"Walaupun tiada tarikh tutup untuk pendaftaran SKPS ini, namun nasihat saya kepada semua syarikat supaya segera

mendaftar kerana semuanya di atas talian, elakkan bertindak di saat akhir.

"Ia perlu bagi memastikan mereka boleh guna terus atau segera dapat manfaat sebaik saja pelaksanaan penyasaran subsidi RON95 bermula.

"Jika selepas dimulakan baru mendaftar, kemungkinan mereka akan rugi kerana terpaksa membeli RON95 dengan harga pasaran yang jauh lebih mahal sebelum permohonan mereka SKPS diluluskan," tegasnya.

Justeru katanya, semua syarikat terlibat harus memanfaatkan peluang disediakan kerajaan ini kerana kemudahan ini juga dapat mengurangkan impak kepada rakyat yang juga pengguna. —Iskandar Dzulkifli



纳闽检查 57 家商店仅 1 家违规 价格与供应总体稳定

(本报纳闽 18 日讯) 纳闽国内贸易及生活成本部在一次检查行动中, 援引《1972 年度量衡法令》(第 71 条文) 对一名零售商发出罚单。

该执法行动是因为该商家使用的商业秤未按规定进行重新校验, 此行为已影响交易的透明度并损害消费者权益。

此次行动由五名执法人员组成的队伍执行, 涵盖村区周边的杂货店与迷你市场。此次行动也响应消费者对加强村区商店监督的投诉。

此外, 对另外 56 家营业场所的检查结果显示, 受控品供应充足, 商家有遵守价格管制规定及有关法令。纳闽国内贸易及生活成本部强调, 所有商家有义务对所使用的秤具进行定期重新校验, 以确保度量准确, 保障消费者权益。

私藏124萬公升柴油 3男面控或罰百萬

(瓜雪18日讯)因涉及2024年在适耕庄海口渔村非法囤积及转运柴油的3名男子，在昨日被国内贸易及生活费部控上瓜雪地庭，面对抵触1961年供应管制法令的多项控状。

有关案件源自雪州内贸局与雪州警方联合突击，揭发当地一间无名仓库，私藏大量补贴渔用柴油，涉及总量高达124万公升。

一人未出庭

雪州内贸局发文告指出，根据控状，3名在昨日被传召上庭者(接传票人)

皆为本地男子，年龄50岁以下；另一人则未有出庭，当局正追查下落。

控状指出，被告于2024年期间，在适耕庄海口渔村进行未持有批发执照的柴油交易活动，涉及受管制补贴柴油，抵触1974年供应管制条例第3(1)条文，可在1961年供应管制法令第22(1)及(2)条文下受惩。

其中两名被告被控非法以批发方式交易柴油，而另一名被告则被发现管控大量柴油，情况足以引发合理怀疑，其意图是非法销售或批发补贴柴油，构成刑事行为。

案件由雪州内贸局检控组副检控司诺哈西玛代表提控，主审法官为努鲁玛蒂雅。

若罪名成立，个人初犯将面临最高100万令吉罚款、监禁最多3年或两者兼施。重犯者将被罚款高达300万令

吉、监禁最多5年或两者兼施。若涉及公司，罚款金额分别为首次最高200万令吉，重犯高达500万令吉。

雪内贸局强调，将持续加强执法力度，遏止非法交易津贴物资的行为，保障国家财政及公众利益。

Farmers: Set realistic floor price

Last revision of local white rice was done 17 years ago, govt told

PETALING JAYA: Rice farmers and retailers are urging the government to set a realistic floor price to secure food sovereignty and stabilise supply.

According to them, this is necessary because outdated price controls and the RM2.60 per kg ceiling for local white rice are no longer sustainable due to rising costs.

Malaysia Padi Farmers Brotherhood Association chairman Abdul Rashid Yob proposed a price band of RM3.20 to RM3.80, or alternatively the removal of the ceiling price altogether, to allow the industry to adjust to global currency movements and ensure long-term stability.

"The supply of local rice is there, but millers cannot sustain RM2.60 when production costs are already at RM3. The problem lies in the price itself. To harmonise the industry, the government must introduce a floor price," he said.

"This way, farmers can breathe, millers can keep operating, and consumers will still have access to affordable rice."

To cushion the impact on households, Abdul Rashid suggested increasing monthly subsidies under the Sumbangan Asas



Rahmah (Sara) programme.

"Even if it costs the government an extra RM3bil or RM4bil, it has a duty to safeguard our food sovereignty," he said.

Abdul Rashid noted that the last revision of the local white rice price was 17 years ago, despite surging costs.

"Farmers now spend RM1,500 to produce one metric tonne of padi. The government must review the purchase price and

raise it to RM1,800 per tonne to reflect today's realities," he said.

The local white rice subsidy scheme, which ran from March to August, distributed 2.4 million bags of 10kg subsidised local rice at RM26 each across Peninsular Malaysia, benefiting 400,000 low-income households.

While the scheme ended on Aug 31 and has not been extended, Agriculture and Food Security Minister Datuk Seri Mohamad

Sabu said the government is reviewing the supply mechanism and monitoring prices to ensure continued access to affordable rice.

Mydin managing director Datuk Ameer Ali Mydin echoed similar concerns, saying that price controls were the main reason behind shortages.

"No supplier is willing to sell at the controlled price of RM26 per 10kg because the subsidy is gone.

"First, remove price controls and let the market find its level. Then we will know if local rice is sellable," he said.

He noted that imported rice now retails at RM30 to RM32 per 10kg, making the narrow price gap unattractive for local rice.

"The government wants to give the B40 group cheaper rice, but the reality is there is no cheaper rice. Everyone is buying imported rice at different prices. It's better to have rice in the market than none at all," he added.

Ameer estimated that once subsidies are removed, local rice could rise to around RM29 per 10kg.

"But people must remember our local rice is of very good quality. The market should decide based on price and quality," he said, calling for at least a RM4 to RM5 price gap between local and imported rice to keep demand for local varieties strong.

A rice wholesaler, who did not want to be named, said producers had struggled to maintain supply since the subsidy ended.

"With subsidies, we could still support local rice production. But now, without aid and with rising costs, selling at RM2.60 per kg means we are effectively operating at a loss," he said, adding that promised subsidies had yet to be disbursed.
