AKTA KAWALAN BEKALAN 1961

PERATURAN-PERATURAN KAWALAN BEKALAN (LARANGAN IMPORT) 2021

PADA menjalankan kuasa yang diberikan oleh perenggan 6(2)(b) Akta Kawalan Bekalan 1961 [Akta 122], Menteri membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kawalan Bekalan (Larangan Import) 2021**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 26 November 2021.

**Tafsiran**

2. Dalam Peraturan-Peraturan ini, “import” ertinya membawa atau menyebabkan dibawa masuk barang kawalan ke dalam Malaysia, melalui darat, laut atau udara atau dengan apa-apa cara.

**Larangan import**

3. (1) Mana-mana orang tidak boleh mengimport apa-apa barang kawalan yang dinyatakan dalam Jadual dari mana-mana destinasi, melainkan dengan kebenaran bertulis Pengawal Bekalan.

(2) Pengawal Bekalan boleh mengenakan apa-apa syarat sebagaimana yang difikirkannya patut dalam kebenaran bertulis yang dikeluarkan di bawah subperaturan (1).

(3) Mana-mana orang yang melanggar peraturan ini melakukan kesalahan.

**Kecualian**

4. (1) Apa-apa kelulusan pengimportan yang dikeluarkan di bawah Akta sebaik sebelum tarikh permulaan kuat kuasa Peraturan-Peraturan ini hendaklah kekal sah dari tarikh permulaan kuat kuasa Peraturan-Peraturan ini, sehingga dipinda, digantikan, ditamatkan atau dibatalkan.

(2) Apa-apa permohonan import yang dibuat di bawah Akta dan yang belum selesai sebaik sebelum Peraturan-Peraturan ini berkuat kuasa hendaklah diuruskan di bawah Peraturan-Peraturan ini seolah-olah permohonan itu dibuat di bawah Peraturan-Peraturan ini.

CONTROL OF SUPPLIES ACT 1961

CONTROL OF SUPPLIES (PROHIBITION ON IMPORT) REGULATIONS 2021

IN exercise of the powers conferred by paragraph 6(2)(b) of the Control of Supplies Act 1961 [Act 122], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Control of Supplies (Prohibition on Import) Regulations 2021**.

(2) These Regulations come into operation on 26 November 2021.

**Interpretation**

2. In these Regulations, "import" means to bring or cause to be brought controlled articles into Malaysia, by land, sea or air or by any other means.

**Prohibition on import**

3. (1) Any person shall not import any controlled articles specified in Schedule from any destination, except with the written permission of the Controller of Supplies.

(2) The Controller of Supplies may impose any conditions as he may deem fit in the written permission issued under subregulation (1).

(3) Any person who contravenes this regulation commits an offence.

**Saving**

4. (1) Any approval of importation issued under the Act immediately before the date of coming into operation of these Regulations shall remain valid from the date of coming into operation of these Regulations, until amended, replaced, rescinded or revoked.

(2) Any application for import made under the Act and pending immediately before the coming into operation of these Regulations shall be dealt with under these Regulations as if the application is made under these Regulations.
