PRICE CONTROL AND ANTI-PROFITEERING
(DETERMINATION OF MAXIMUM PRICE) (NO. 5) (REVOCATION) ORDER 2025

IN exercise of the powers conferred by section 4 of the Price Control and Anti-Profiteering Act 2011 [Act 723], the Controller, with the approval of the Minister, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Price Control and Anti-Profiteering (Determination of Maximum Price) (No. 5) (Revocation) Order 2025**.
