SSM siasat dua syarikat tawar skim pelaburan sawit

Suruhanjaya terima 46 aduan, laporan babit bayaran dividen

Kuala Lumpur: Suruhanjaya Syarikat Malaysia (SSM) menjalankan siasatan terhadap dua syarikat yang menawarkan skim kepentingan berbentuk pelaburan kongsi tani berkaitan pena-

naman sawit mengikut Akta Pencegahan Pengubahan Wang Haram, Pencegahan Pembentukan Keganasan dan Hasil Daripada Aktiviti Haram 2001 (AMLA) dan Akta Skim Kepentingan 2016 (ASK 2016).

Buka kertas siasatan

SSM dalam kenyataan semalam, menyebut siasatan itu dijalankan susulan 46 aduan dan laporan berhubung insiden pembayaran pulangan pelaburan dalam bentuk dividen, yang diterima agensi berkenaan membabitkan dua syarikat itu dari April hingga

September lalu.

“Lanjutan daripada aduan itu, pada 25 September lalu, SSM telah membuka kertas siasatan dan melakukan pemeriksaan fizikal di pejabat pengurusan skim berkenaan serta lokasi penanaman sawit bagi meneliti isu yang dibangkitkan.

“Menerusi pemeriksaan yang dijalankan, empat kompaun dieluarkan kepada dua pengarah syarikat, seorang pengurus dan syarikat pengurusan di bawah Seksyen 46(1) ASK 2016 dengan nilai keseluruhan kompaun berjumlah RM1 juta pada 25 Sep-

tember,” menurut kenyataan itu.

SSM memandang serius dakan berkenaan kerana ia menjelaskan amalan tadbir urus korporat baik yang seharusnya dipraktikkan oleh pengarah syarikat.

“Pelabur yang terkesan dengan skim kepentingan berdaftar dan mempunyai maklumat untuk membantu siasatan, disarankan tampil untuk membuat aduan melalui e-mel ke aduan@ssm.com.my atau hubungi 03-2299 4400,” menurut kenyataan itu.

Probe into two firms offering interest schemes

KUALA LUMPUR: The Companies Commission of Malaysia (SSM) has issued four compound notices to RM1mil, to East-West Horizon Plantation Berhad (EWHPB), its two directors and a manager for breaching Section 46(1) of the Interest Schemes Act 2016.

According to a statement issued by SSM yesterday, the compound notices were issued last Sept 23.

It said EWHPB and another company, known as East West One Consortium Berhad (EWOCB), were offering an interest scheme in the form of shared farming investment related to oil palm cultivation and managed by East West One Group (EWOG). They were investigated by the commission following complaints lodged against them.

"The investigation was carried out fol-

lowing 46 complaints and reports received by the agency involving the two companies from April to September last year.

"On Sept 25, SSM opened an investigation paper and carried out a physical inspection at the management offices of the companies concerned, as well as the oil palm plantation to examine the issues raised," read the statement, Bernama reported.

It also said the commission takes seriously such allegations as they affect good corporate governance practices that should be practised by company directors.

"Investors who are affected by the interest schemes managed by EWOG and have information to assist the investigation, are advised to make a complaint via email to aduan@ssm.com.my or call 03-2299 4400," it said.
