Armizan buat kunjungan hormat ke atas Menteri Perdagangan Turkiye

PETALING JAYA — Menteri Perdagangan Dalam Negeri dan Kos Sara Hidup, Datuk Armizan Mohd. Ali mengadakan kunjungan hormat ke atas Menteri Perdagangan Turkiye, Prof. Dr. Omer Bolat.

Menurut beliau, kunjungan tersebut membincangkan pelbagai perkara melibatkan aspek tanggungjawab berkaitan kedua-dua kementerian seperti perdagangan dalam negeri, perlindungan pengguna, perundungan persaingan dan isu kos sara hidup.

Armizan berkata, MoU tersebut adalah langkah strategik untuk memperkuuhkan kerjasama antara kedua-dua agensi dalam menghadapi cabaran yang semakin kompleks dalam

Six foreigners jailed for unlawful petrol possession in Sandakan

SANDAKAN: Six foreigners, aged between 25 and 45, were jailed twelve months each by the Sessions Court here on Tuesday for possessing 41,000 litres of petrol without a licence.

The accused pleaded guilty before Sessions Court Judge Zaini Fishir @ Fisal to a charge under Section 21 of the Control of Supplies Act 1961 read together with Regulation 3(1) of the Control of Supplies Regulations 1974.

All the accused, who were crew members of MT Rahmah vessel, were found having the controlled goods at 9pm on Aug 21,

2023, at the waters near Kg Cenderamata, here.

The raid on MT Rahmah was conducted by the General Operations Force (PGA), and an inspection revealed that the vessel was carrying 41,000 litres of petrol without any valid documentation.

The case was subsequently handed over to the Sandakan branch of the Ministry of Domestic Trade and Cost of Living (KPDN) for further investigation and action.

Judge Zaini ordered the confiscation of the vessel, MT Rahmah, and relevant equipment while proceeds from the sale of the

seized petrol will be forfeited by the Malaysian government.

KPDN Sabah Deputy Public Prosecutor Md. Syafique Md. Hilmie appeared for the prosecution while all the accused were represented by Tan Arthur Borine & Partners.

Meanwhile, the Chief Enforcement Officer of the Sandakan KPDN Branch, Azdy Zukkry John, stated that his department will continue to carry out inspections and enforcement under "Operasi Tiris" to combat any activities involving the misappropriation and leakage of petrol and diesel in the district. — *James leong*



昌明愛心促銷 10月起 含糖商品不再折扣

(吉隆坡11日讯)国内贸易及生活费部副部长傅芝雅表示，10月1日起，昌明爱心促销（MADANI Rahmah Sale）活动的折扣商品列表中将会移除所有含糖食品和饮料。

她表示，此举旨在支持卫生部主导的“反糖战争”运动，鼓励公众减少摄取糖份。

“我们将从爱心促销列表中移除含糖商品，不再提供折扣。”

她说，爱心促销活动此前对含糖商品（如甜炼乳）提供10%至30%的折扣。

傅芝雅沙烈是于今日推介“Jom Kosong”计划后，对记者如是指出。

竞委会自成立以来，已调查超过 100 家公司，其中涉及垄断利益集团和不当垄断等各类反竞争的案件。

阿米占补充，其部门将继续致力于确保经济平衡发展，并保护消费者利益。

SHAH ALAM (Sept 11): The High Court on Wednesday dismissed a judicial review application filed by five warehouse operators to quash the decision by the Malaysian Competitions Commission (MyCC) and that of the Competition Appeal Tribunal (CAT) to impose penalties totalling more than RM1 million on them in 2021.

Judicial Commissioner Jamhirah Ali ruled there was no irrationality, illegality and/or procedural impropriety in either the MyCC and CAT's decision that warranted the court's intervention to quash their decision on the imposition of the penalties.

Jamhirah said the court also agreed with MyCC and CAT's findings that the warehouses had committed an infringement of Section 4 of the Competition Act 2010 — which prohibits any horizontal or vertical agreement between enterprises that could prevent, restrict or distort competition in any market for goods and services — and hence, were not entitled to a relief to challenge liability under Section 5 of the same Act.

Section 5 provides that an enterprise involved in such an agreement may be relieved of its liability for the infringement

of the prohibition if: i) there are significant technological, efficiency or social benefits that arise from the agreement; ii) the benefits could not reasonably have been provided without the effects of preventing, restricting or distorting competition; iii) the detrimental effects of the agreement on competition is proportionate to the benefits it provides; and iv) the agreement does not allow the enterprise concerned to eliminate

competition completely over a substantial part of the goods or services involved.

MyCC was represented by Kwan Will Sen and Muayyad Khairulmaini in the proceedings that were conducted online.

Kwan, who confirmed the court's decision when contacted by *The Edge*, said Jamhirah also imposed total costs of RM5,000 to be paid by the five warehouses.

The five warehouses were SAL Agencies Sdn Bhd, WCS Warehousing Sdn Bhd, Regional Synergy (M) Sdn Bhd, Intrexim Sdn Bhd and Pioneerpac Sdn Bhd.

In 2021, it was reported that MyCC had imposed a total penalty of RM1.04 million on seven warehouses for price-fixing offences in the handling of cargoes in Port Klang between May 2017 and December 2019. The penalties ranged between RM26,363.03 to RM336,369.13 for each company.

The operators were found to have engaged in a price-fixing cartel in relation to the handling of services for import and export cargoes, which constituted an infringement under Section 4 of the Competition Act 2010, MyCC said in a 2021 statement.
