Now you see it, now you don't

A local white rice story

So there is enough local white rice in the system after all. The only problem is that the mysterious Malaysian grain is stuck somewhere. Packets of them. And the "somewhere" might just be in the cartels' warehouses, if Kedah Menteri Besar Datuk Seri Muhammad Sanusi Md Nor is right. On Friday, he disclosed to reporters the reason for the shortage of local white rice priced at RM26 per 10kg packet: cartels are allegedly getting it out of the system and repackaging it as imported rice at significantly higher prices. Tokai assemblyman Datuk Dr Mohd Hayati Othman told a similar story to the Kedah state assembly on Nov 25, blaming the shortage on irresponsible millers repackaging it as imported rice. As evidence, he quoted one rice mill worker admitting to doing the repackaging on the orders of the mill owner. With millers like this, who needs a cartel? If this is true, gluttonous millers are creating a shortage to harvest the difference between the government-controlled price of RM26 per 10kg packet of local rice and the "market"-determined price of imported rice, ranging from RM35 to RM44. Sanusi, however, didn't provide any evidence except to say that cartels have been at the repackaging trade for some time now, from seeds to rice supply to rice prices. That is like almost the whole rice industry. Interestingly, Sanusi wants the government to give the Kedah authorities control over the rice industry to restore the supply of local rice. Equally interestingly, the chairman of the National Action Council on Cost of Living Task Force (Food Cluster), Datuk Syed Abu Hussin Hafiz Syed Abdul Fasal, too, wants the government to give him control over the rice industry, promising resolution to the issue within three months. Cartels didn't feature in his statement.

Cartels or no cartels, the problem needs an immediate solution. This has gone on for close to two years and the people are left wondering how such visible things like 10kg rice packets can go missing under the very nose of the authorities. Is there or isn't there a cartel? The answer is as simple as yes or no. When a study is involved — the Malaysia Competitive Commission has finished a report on cartel activities in the padi and rice industry — it does take quite a while for either answer to come our way. On Nov 6, Deputy Domestic Trade and Cost of Living Minister Fuziah Salleh told Parliament so when responding to questions on all things local rice. Fuziah didn't disclose details of the report, but did hint at abuse of power, as this newspaper reported from the august house, whatever that phrase means. We may have to wait yet again for the report to be made public. Or will it be?

If the answer is "yes" to cartels, then go out and get rid of them for good. If "no", what else is the problem? Tell us. The people need to know. A staple diet mustn't be treated this way. Consumption of three million tonnes a year must mean something. If the people can't get their hands on locally produced rice, they must, at the very least, be told why.

Over 6,000 business premises inspected

PUTRAJAYA: A total of 6,007 business premises were inspected nationwide during the Festive Season Maximum Price Scheme (SHMMP) in conjunction with the Chinese New Year (CNY) celebration which ran from Jan 25 to Feb 2.

Domestic Trade and Cost of Living Ministry (KPDN) Enforcement Director-General Datuk Azman Adam said the inspections covered 108 wholesale premises and 5,899 retail premises.

"Throughout the enforcement period, 483 cases were recorded against traders who failed to comply with the regulations. This led to seizures worth RM21,942.85, mainly for offences such as not displaying

price tags and not using pink price tags," he said in a statement Wednesday.

Azman confirmed that no cases of traders selling above the maximum price were detected, and no complaints were received during the scheme's implementation.

He added that most traders adhered to the regulations and were committed to complying with the price control measures.

The SHMMP was enforced for nine days - four days before Chinese New Year, one day during the festival, and four days after, with 16 essential items placed under price control. - Bernama

RM13b untuk STR, Sara

Langkah bantu rakyat tangani kenaikan kos sara kehidupan

Kerajaan memperuntukkan hampir RM13 bilion bagi inisiatif Sumbangan Tunai Rahmah (STR) dan Sumbangan Asas Rahmah (Sara) dalam usaha membantu rakyat menangani kenaikan kos sara hidup.

Timbalan Menteri Ekonomi, Datuk Hanifah Hajar Taib berkata, sebanyak RM300 juta pula diperuntukkan bagi pelaksanaan inisiatif Payung Rahmah manakala RM700 juta bagi program mengawal harga barang menerusi usaha sama dengan pelbagai pihak.

"Sementara itu, bagi Program Penyeragaman Harga Barang di Sabah, Sarawak dan Labuan, sebanyak RM40 juta turut diperuntukkan," katanya ketika sesi soal jawab di Dewan Rakyat di sini, semalam.

Beliau menjawab soalan **Wong Chen (PH-Subang)** berhubung saranan Jabatan Perangkaan Malaysia (DOSM) ke arah memerangi kenaikan kos sara hidup seperti yang diterbitkan di bawah laporan Indikator Kos Sara Hidup.

Hanifah Hajar berkata, laporan Indikator Kos Sara Hidup 2023 yang dilancarkan tahun lalu me-

ngandungi Perbelanjaan Asas Kehidupan Wajar (PAKW) dan Indeks Kos Sara Hidup bagi mengukur kos sara hidup dengan lebih berkesan.

Sehubungan dengan itu, bagi memudahkan rakyat, beliau berkata, kerajaan turut menyediakan kalkulator sebagai panduan untuk merancang perbelanjaan dan juga pengurusan kewangan keluarga menerusi aplikasi MyPAKW yang boleh dicapai pada laman sesawang mypakkw.dosm.gov.my.

Hanifah Hajar berkata, kerajaan melalui Majlis Tindakan Sara Hidup Negara (Naccol) melaksanakan usaha berterusan bagi mengatasi isu kenaikan kos sara hidup rakyat dengan memberikan tumpuan kepada tujuh kluster keutamaan meliputi perumahan, pendidikan, pengangkutan, utiliti, kesihatan, makanan dan pendapatan.

Beliau berkata, sistem Pangkalan Data Utama (Padu) yang mempunyai profil bagi semua 30.1 juta individu warganegara dan pemastautin tetap di Malaysia juga membolehkan kerajaan menjalankan pemantauan dan penilaian secara berkesan bagi membantu rakyat mendepani cabaran peningkatan kos sara hidup.

RM13b allocated for cash aid to ease living costs

KUALA LUMPUR: The government has allocated nearly RM13 billion for the Sumbangan Tunai Rahmah and Sumbangan Asas Rahmah cash aid initiatives aimed at helping Malaysians cope with rising living costs, said Economy Deputy Minister Datuk Hanifah Hajar Taib.

She said an additional RM300 million has been set aside for the Payung Rahmah initiative, while RM700 million has been allocated for price control programmes through partnerships with various stakeholders.

"For the Price Standardisation Programme in Sabah, Sarawak and Labuan, RM40 million has been allocated," she said in the Dewan Rakyat yesterday.

She was responding to a question from Wong Chen (PH-Subang) regarding recommendations by the Statistics Department to combat rising living costs as outlined in the Cost of Living Indicator Report.

Hanifah added that the report, released last year, includes the Basic Expenditure of Decent Living and Cost of Living Index to better assess living costs.

She said the government has introduced a calculator aid to help families plan their expenses, Bernama reported.

The MyPAKW app, accessible via mypakw.dosm.gov.my, serves as a financial management guide.

She added that the National Action Council on Cost of Living is working to address the issue of rising living costs, focusing on seven priority areas, namely housing, education, transportation, utilities, healthcare, food and income.

Hanifa said the Central Database Hub, which contains profiles of 30.1 million Malaysian citizens and permanent residents, allows for effective monitoring to support those struggling with the cost of living.

Pengusaha dodol 'pening' bekalan kelapa kurang

PONTIAN: Seorang pengusaha dodol bimbang susulan bekalan kelapa yang semakin berkurangan menjelang bulan Ramadan dan sambutan Hari Raya Aidilfitri yang bakal tiba tidak lama lagi.

Halinda Haron, 50, berkata, bekalan kelapa yang mencukupi merupakan elemen penting dalam pembuatan kuih tradisional itu.

Bagaimanapun katanya, sejak bulan lalu bekalan kelapa tempatan berkurangan disebabkan faktor 'melawas' atau kekurangan buah serta permintaan tinggi dalam aktiviti ekonomi lain termasuk daripada pengusaha santan yang memerlukan bekalan banyak setiap hari selain peniaga nasi lemak.

"Disebabkan kekurangan bekalan kelapa, saya terpaksa membeli kelapa yang diimport dari Indonesia dengan harga RM2.80 sekilogram (kg) di jeti Tongkang Pechah, Batu Pahat. Sebanyak 700 kilogram bersamaan 678 biji dibeli dengan harga RM1,820 tidak termasuk kos penghantaran," katanya kepada *Utusan Malaysia* di rumahnya di Lorong Tengah, Kampung Rimba Terjun, dekat sini.

Pada hari biasa, dia memerlukan kira-kira 300 biji atau 1,200 biji kelapa sebulan bagi mem-

buat dodol yang menggunakan jenama 'Dodol Makndak' menggunakan tiga kawah besar.

"Setiap kawah pula menggunakan 35 kg santan kelapa, 15 kg pulut dan 25 kg gula merah yang dimasak selama 10 jam supaya benar-benar masak," katanya yang memulakan perniagaan itu ketika pelaksanaan Perintah Kawalan Pergerakan (PKP) Covid-19.

Namun dia akan berusaha bagi mendapatkan bekalan kelapa tempatan yang dibeli dengan harga antara RM1 hingga RM1.50 sebijji, sebelum memikirkan alternatif lain.

Katanya, pengeluaran Dodol Makndak bagi sambutan Aidilfitri biasanya mencapai tiga tan berbanding antara 800 kg hingga satu tan sebulan di luar musim perayaan.

Halinda mengakui cabaran utama ketika ini adalah bagi mendapatkan bekalan kelapa tempatan untuk memenuhi tempahan daripada pelanggan yang biasanya bermula pada hari pertama Ramadan.

"Kami juga bimbang berlaku kenaikan harga kelapa, sekali gus menyebabkan harga dodol terpaksa dinaikkan bagi menampung kos," katanya.

'STR aid has eased rising cost of living'

KUALA LUMPUR: The government has introduced several measures, including the Sumbangan Tunai Rahmah (STR) cash aid, to ease the rising cost of living. This follows findings from the 2023 Cost of Living Indicator Report, which found increased prices for goods and services last year. Deputy Economy Minister Datuk Hanifah Hajar Taib said the government was concerned about the challenges citizens faced in maintaining a decent standard of living.
