Affordable essentials available at Rahmah sales programme drive in Sibu this weekend

SIBU: The Jualan Rahmah Madani Programme (PJRM) will take place at Dewan Kompleks Islam Sibu tomorrow and Aug 10, running from 8am to 5pm, offering essential items at affordable prices to help the public cope with the rising cost of living.

In a statement yesterday, the Ministry of Domestic Trade and Cost of Living (KPDN) said the initiative is part of the federal government's ongoing effort to ease financial pressure on the people, especially those in the B40 group and residents in both urban and rural areas.

"This programme is one of the government's proactive approaches to safeguard the welfare of the people, particularly in light of current economic challenges," the statement read.

Under PJRM, basic necessities will be sold at discounted prices through strategic partner outlets and mobile sales units, ensuring continued access to quality goods at stable prices.

The Sibu event is part of a wider rollout of PJRM throughout Sarawak this week, with several other districts hosting similar sales to reach more communities.

Paparan harga ubat di fasiliti kesihatan swasta dianggap tak wajar, mengelirukan

Kuala Lumpur: Langkah kerajaan mewajibkan paparan harga ubat, mengeluarkan preskripsi dan bil terperinci bagi setiap pesakit yang menerima rawatan di fasiliti kesihatan swasta bermula 1 Ogos lalu disifatkan tidak wajar dan mengelirukan.

Tindakan itu menunjukkan Kementerian Perdagangan Dalam Negeri dan Kos Sara Hidup (KPDN) melalui Akta Kawalan Harga dan Antipencatutan 2011 (Akta 723) ‘campur tangan’ dalam perkara yang di luar bidang kuasanya.

Presiden Pertubuhan Doktor-Doktor Islam Malaysia (PERDIM), Dr Boi Saidi Abd Razak, berpendangan Akta Kemudahan dan Perkhidmatan Penjagaan Kesihatan Swasta 1998 (Akta 586) di bawah Kementerian Kesihatan (KKM) yang ketika ini mengawal operasi klinik swasta

sudah memadai.

“Kami pengamal klinik swasta (GP) tidak bersetuju Akta 723 berkaitan paparan harga ubat di klinik swasta digunakan. PERDIM turut berpendapat bahawa tatakelola klinik swasta adalah di bawah Akta 586 dan ia di luar bidang kuasa KPDN Dan Majlis Tindakan Sara Hidup Negara (NACCOL).

“Kami berpendapat semua akta sedia ada di bawah KKM sudah memadai untuk mengawal selia operasi klinik swasta di Malaysia.

“Jika KKM membabitkan KPDN, ini akan menyebabkan timbul kekeliruan di antara pemegang taruh kesihatan,” kata

nya kepada BH, di sini semalam.

Mengulas lanjut, Dr Boi Saidi berkata, peruntukan dalam Akta 586 jelas menyatakan klinik swasta tidak wajib mengeluarkan preskripsi dan bil terperinci kepada semua pesakit yang mendapatkan rawatan di klinik swasta, sebaliknya ia hanya akan dikeluarkan atas permintaan pesakit.

Justeru, beliau menggesa KPDN meneruskan kajian supaya tidak sesekali mengeluarkan kenyataan yang mengelirukan rakyat dan pemegang taruh kesihatan di negara ini.

Ketika sesi Pertanyaan-Pertanyaan Bagi Jawab Lisan di

Dewan Rakyat kelmarin, Timbalan Menteri Perdagangan Dalam Negeri dan Kos Sara Hidup, Dr Fuziah Salleh, dilaporkan berkata bermula 1 Ogos, semua klinik dan farmasi diwajib memaparkan harga ubat secara telus sebagai sebahagian usaha kerajaan memperkasa hak pengguna dalam sektor kesihatan.

Fuziah dilaporkan berkata, keputusan itu antara inti pati utama yang dipersetujui dalam Mesyuarat NACCOL dan Jawatankuasa Eksekutifnya yang berlangsung tahun ini, selain mewajibkan preskripsi ubat selepas setiap sesi perundingan dengan doktor.

Ahad lalu, KKM dalam satu kenyataan memaklumkan kekal dengan pemberian tempoh tiga bulan advokasi bagi pelaksanaan Akta 723, bermula sejak 1 Mei lalu.

Foreigner held for alleged cooking oil scam

LAHAD DATU: Police have arrested a foreigner for allegedly deceiving people into paying for subsidised cooking oil, and failing to deliver the purchased items.

District Police Chief, ACP Dzulbaharin Ismail said the woman was detained by the Commercial Crime Investigation Division following a report lodged by the victim.

He said the suspect's modus operandi was to sell the cooking oil wholesale at an attractive price.

"However, when she received the payment, she would use it to pay for her debt and failed to continue the cooking oil business with the victim.

"Preliminary investigation found that the suspect did not have the Scheduled Controlled Goods (CSA) licence from the Ministry of Domestic Trade and Cost of Living (KPDN)," he said.

Dzulbaharin said the suspect is currently in their custody for further investigation under Section 420 of the Penal Code.

Police urged members of the public to always be cautious while making any transaction especially involving subsidised items online or without license.
